Addendum to Conditions of Employment Governing:

- Academic Teaching Staff Professors, Readers, Senior Lecturers, Lecturers and Instructors, including Clinical Academic Teaching Staff (other than those on the 'New Clinical Contract'): paragraphs 35 – 39
- Research and Analogous Staff Senior Fellows, Senior Research Fellows, Research Fellows, Research Associates and research analogous staff, including research staff with the title of Reader and Clinical Research Staff (other than those on the 'New Clinical Contract'): paragraphs 36 – 40
- Clinical Academic Teaching and Research Staff Holding Honorary Consultant Medical or Dental Contracts in National Health Service Organisations (ie the 'New Clinical Contract'): paragraphs C50 – C55
- Academic Information Services Staff: paragraphs 36 40

Following a decision of the University Council in July 2008, the paragraph numbers of the conditions of employment referred to above notwithstanding, new procedures have been adopted which replace and extend appendices 7 (Disciplinary Procedure), 8 (Appeals) and 9 (Grievance Procedure) which are withdrawn. With effect from 1 January 2009 the following University Ordinances apply:
