ORDER

UPON HEARING Counsel for the Claimant on a without notice application pursuant to an Application Notice dated 21 January 2015

AND UPON READING the Third Witness Statement of Carolyn Pike dated 20 January 2015 and the Witness Statement of James Edward Roger Fownes dated 21 January 2015

1. The validity of the Writ of Possession dated 5 February 2014 is extended for a period of 12 months, from 5 February 2015 (being the next day following the day on which the Writ of Possession would otherwise expire) to 4 February 2016 inclusive.
2. Pursuant to CPR 6.15 and 6.27, this Order shall be served by the method of attaching copies to conspicuous places within that part of the Campus of the University of Birmingham, Edgbaston, Birmingham shown edged red on the Plan attached to the Order dated 3 February 2015.
3. This Order shall be deemed to be served on the date of affixation in accordance with the method referred to in paragraph 3 above, as verified by an affidavit of service.
4. A Defendant or any other person affected by the Order may apply to vary or set aside this Order within 7 days of service of this Order as aforesaid, but if he wishes to do so he must first inform the Claimant's solicitors in writing to the address referred to in paragraph 6 below at least 24 hours beforehand.

5. A Defendant or any other person affected by this Order who wishes to obtain copies of the evidence relied upon in support of the Application Notice dated 21 January 2015 shall, upon first having provided the Claimant's solicitors (at the address referred to in paragraph 6 of this Order) with their name and address for service, be provided with copies of such evidence as soon as reasonably practical thereafter.
